#### 5. Old Business

a. Title 2\* (Carrie Albright, Rachael Johnson)

Rachael passed the EC's Title 2 recommendations to the legal department, which had a few recommendations. David caught that we had intended to shorten the commission's name, which was not reflected in the packet. Rachael shared some small grammar and conciseness in the suggested writings. David agreed with the suggestions, and other members agreed as well.

David Parkhurst motioned to approve Title 2 recommendations; Mitchell Owens seconded. All present voted yes.

b. Priorities for 2025 (Carrie Albright, Matt Caldie, Karenna Tankersley)

Carrie discussed how the Chair, Vice Chair, and Secretary have been envisioning the EC's future priorities, including onboarding new appointees within a month of appointment, and reframing the

bucket list meeting and focusing on SMART goals, to ensure we can actually act on the EC priorities. The previously named "bucket list" meeting would be moved from January to the November meeting, and would include determining which working groups would be prioritized. Carrie shared that moving into the future, there would be an expectation that EC members would be actively involved in at least one working group, and that ideally the working groups would have clearer project scopes and would provide quarterly updates.

Karenna asked about the timing of the EC Overview meeting, and Carrie and Karenna agreed that March would make sense to catch up new appointees and allow them to share their ideas and ask questions. Matt asked about whether officer elections should be pushed to March as well. Nadia pointed out that the March meeting would likely fall on Indiana University's Spring Break, which would likely create conflict for students during the March EC meeting.

  - a. Earth Day 2025 / EcoHeroes Discussion (Fiona Kilgore)

Fiona floated multiple ideas for Eco Heroes themes including car-free futures, habitat connectivity, pollinators and low waste. Mitchell and Carrie mentioned that the pollinator theme would match the BDWG of pursuing Bee City USA certification. The idea of urban ecosystems as a theme was also floated. Matt asked how long we have before a theme decision was needed, and Rachael answered that the EC would need a decision around January.

#### b. Composting / Title 6 Discussion (Rachael Johnson)

John Hewitt from Housing and Neighborhood Development Department received a questionnaire about city interest in composting, and asked to be in the loop if it comes up in future EC meetings. Matt and Karenna mentioned that BCOS usually initiates composting initiatives.

Haskell Smith mentioned that 71 trees have been planted recently. I 100 had been planted on a grant for the past year. Canopy Bloomington asked to give a presentation to the TC in the future.

Legal suggested that the TC should be involved in tree appeals.

Matt mentioned that if Haskell wants a letter of support from the EC for a future grant, the EC would be open to that.
