Project Details

Project Narrative

GardenQuest, a Covenanter neighborhood non-profit focusing on educational sustainability initiatives and urban farm-to-table instruction, would like to offer a location for neighbors to drop-off household items that are recyclable through Terracycle, but not through the City of Bloomington's recycling service.

What is Terracycle? In a nutshell, Terracycle is a company that has created a closed loop recycling/reuse process for household and business items that are not recycle through typical municipal methods.

Since this program will be located within a neighborhood, the footprint of the recycling operation must remain small. With more than 300 product/options, neighbors who are interested in reducing their waste through Terracycle, will fill out a survey to narrow down the recyclables to the 3 most popular product categories. Terracycle Zero Waste boxes for the products in these categories will be purchased with grant funds.

The recycling boxes will be located in an accessible location for all participating neighbors, but safely tucked within a corner of the Spier Family's carport (property out of which GardenQuest operates) to dissuade animals from disturbing the boxes.

Once a box in a particular category is filled, GardenQuest will ship it to Terracycle with the prepaid label and purchase another one. While funding limits how many paid Zero Waste Terracycle boxes can be purchased, GardenQuest plans to add applicable business sponsored boxes (free programs with brand specific items) to the list of recyclables for the neighborhood. GardenQuest also hopes to expand options for the neighborhood by researching what businesses in Bloomington already sponsor Terracycle boxes and promote the usage.

If Terracycle proves itself through this pilot to align with the city's waste reduction and recyclable diversion CAP goals, GardenQuest will reapply annually for funding to purchase boxes that are not provided elsewhere in the community and will coordinate the program for the neighborhood.

Project Deliverables

GardenQuest will purchase Terracycle boxes based on the top three non-recyclable waste stream items, based on a survey of the participating neighbors. The volume and weight of each box will be recorded prior to shipping.

Once grant funds run out, GardenQuest will send out a post-program survey. GardenQuest will provide pre- and post survey results to BCOS.

Terracycle is a business that directly diverts waste from Bloomington's landfills. Better yet, the waste is not thrown-away somewhere else. Terracycle's operations and business model closes the loop. All waste stream products collected have either end-of-life buyers or Terracycle recycles them and makes new products. Terracycle's recycling facilities are centrally-located in the Midwest, with the closest facility to Bloomington in Illinois.

By providing this program, GardenQuest will be able to increase recyclables diversion, which is the goal of WM 1-B.

How does this project support Bloomington's overall sustainability goals? While a Terracycle box for a single household may be price-prohibitive, this program provides the opportunity for neighbors to work together to actively participate in diverting recyclables from the landfill. Having a drop-off point within a neighborhood provides a level of convenience and accessibility that is limited with business and city drop-off points, which may encourage more participation and lessen the transportation ecological footprint of each neighbor.

By giving GardenQuest and its neighbors the chance to put into practice a small waste reduction program, the program is becoming part of the progression to Bloomington's ultimate sustainability solution no matter what the results show.

Residents in the Covenanter neighborhood are looking for ways to reduce the amount of waste coming from their homes and going to the landfill. The project will increase resident and community awareness that recycling options exist for many items that end up in Bloomington's landfill.

The hope is that GardenQuest's pilot program for Covenanter residents results in a successful reduction in recyclables heading to the landfill, which inspires other neighborhoods to request funding for Terracycle as well.

Expected Challenges

The challenge with this project will be filling up the Zero Waste boxes quickly and running out of funds to continue diverting the most popular neighborhood recyclables, disappointing residents.

To overcome these challenges, options include:

- 1. Reapplying for BCOS funding
- 2. Applying for alternative funding
- 3. Surveying residents to see if makes sense to cost-share to purchase additional boxes.
- 4. Continuing Terracycle using the product-specific, free programs.
- 5. Encourage local businesses to invest in Terracycle Zero Waste boxes to increase commercial participation in Bloomington's CAP recyclable diversion goal. Share this information with residents, so that they can continue to recycle.


