

RELEASE, HOLD HARMLESS, AND INDEMNIFICATION AGREEMENT

WHEREAS, my child, _____, will be participating in a career shadowing exercise with the City of Bloomington Fire Department on the following date(s): _____; and

WHEREAS, this may involve strenuous physical activity, potentially dangerous and life-threatening activities, interaction with live fire, riding in City of Bloomington vehicles, spending time at fire stations owned/operated by the City of Bloomington, and other activities associated with fighting fires and training to fight fires; and

WHEREAS, by my child's participation in this activity, the undersigned assumes the risk for injury or death that may result from his/her child's participation; and

NOW, THEREFORE, in consideration of my child's opportunity to participate in this career shadowing exercise, which is being held by the City of Bloomington Fire Department on the following date(s): _____, the undersigned agrees to the following:

- 1) The undersigned is liable for all damage, expense and loss, including theft, property loss, and long distance telephone charges his/her child causes while participating in the career shadowing exercise. In determining damages, the City of Bloomington will use current replacement value. The City of Bloomington has the rights of collection including recovery of costs of collection and attorneys' fees.
- 2) The City of Bloomington retains the right to control and manage its facilities and may enforce all reasonable rules for its management as determined by the City of Bloomington in its sole discretion. The undersigned agrees his/her child will abide by any such rules, policies and conditions that may be in effect from time to time. The City of Bloomington absolutely forbids the use of its facilities in any manner, or for any conduct, which violates any governmental rule/law.
- 3) If the undersigned, or his/her child, identifies any unsafe activities or conditions, it is the undersigned's, or child's, responsibility to immediately stop all such activities and inform the City of Bloomington of the unsafe activity or condition.
- 4) The undersigned indemnifies the City of Bloomington against all liability and costs, including attorneys' fees, in any way connected with the career shadowing exercise or use or occupancy of any City of Bloomington facility or vehicle. The undersigned bears all responsibility and shall hold the City of Bloomington harmless from any responsibility for any bodily injury, including death, to any and all persons or property damage arising

out of or in any way connected with his/her child's participation in the training course. I, as the undersigned, understand that this Release binds my child, myself, my spouse, and all heirs, executors and administrators of those individuals.

- 5) The undersigned agrees to release, hold harmless and indemnify the City of Bloomington, its employees, officers and agents for any claim or claims arising out of any incident connected with or related to in any way to my child's participation in the career shadowing exercise or riding in a City of Bloomington vehicle. This includes claims for personal injury, death, property damage, and/or other types of harm or injury. I, as the undersigned, understand that this Release binds my child, myself, my spouse, and all heirs, executors and administrators of those individuals.
