It is understood that the release applies to any present or future injuries and that it binds the undersigned, undersigned's spouse, heirs, executors and administrators.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is highly contagious and is believed to spread mainly from person-to-person contact.
